ONE (1) LOT SUPPLY AND DELIVERY OF THREE (3) UNITS REFRIGERATOR, 2-DOOR, NO FROST, INVERTER AND 10 CUBIC FEET FOR USE OF PPA, PMO ZAMBOANGA WITH AN ABC OF PHP75,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of Three (3) Units Refrigerator, 2-door, No Frost, Inverter and 10 cubic feet for Use of PPA, PMO Zamboanga with an ABC of Php75,000.00 on October 1 to 8, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPs), PMO Bulletin Boards;


