ONE (1) LOT SUPPLY AND DELIVERY OF ONE (1) UNIT UNINTERRUPTIBLE, POWER SUPPLY FOR USE OF BAGGAGE X-RAY MACHINE AT THE TEMPORARY PASSENGER TERMINAL BUILDING, PPA, PMO ZAMBOANGA WITH AN ABC OF PHP170,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply and Delivery of One (1) Unit Uninterruptible, Power Supply for use of Baggage X-Ray Machine at the Temporary Passenger Terminal Building, PPA, PMO Zamboanga with an ABC of PHP170,000.00, on October 14 to October 20, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Victorious General Merchandise and Services; 2.) Alex Enterprises, and 3.) Lenin Computer System Inc. Out of the three (3) only Victorious General Merchandise and Services submitted their price quotation. The BAC also received a quotation from Blackwater Resources Inc. which participated through online PhilGEPS' posting.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on October 20, 2022, at 2:00PM. The results were as follows:



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


