WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for **EIGHT (8) UNITS ERGONOMIC CHAIR WITH ARMREST WITH AN ABC OF PHP120,000.00** on September 19 to 25, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: National Commercial; ICON Home Depot, and ZC Filipinas Furniture. Out of the three (3) suppliers, only (1) responded to the RFQ and submitted their quotation envelope before the deadline and received by the BAC Secretariat, to wit: ICON Home Depot. Another supplier submitted their price quotation, LM Enterprises which participated through the PhilGEPS posting and submitted their price quotation;

WHEREAS, the BAC opened the sealed price quotation of supplier on September 25, 2023, at 2:00PM. The results were as follows:
