



**BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL**

ONE (1) LOT SUPPLY OF MATERIALS FOR THE CONSTRUCTION OF OPEN PARKING SHED FOR PPA BOOM TRUCK AT POWERHOUSE, PORT OF ZAMBOANGA, PORT AREA, ZAMBOANGA CITY WITH AN ABC OF PHP179,999.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Materials for the Construction of Open Parking Shed for PPA Boom Truck at Powerhouse, Port of Zamboanga, Port Area, Zamboanga City with an ABC of PHP179,999.00, on October 28 to November 4, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) Dennis Hardware Enterprises Inc., 2.) ZC Pacific Hardware Enterprises, and 3.) Asiatic Trading Corp. Out of the three (3) only two (2) submitted their price quotation.

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on November 4, 2022, at 2:00PM. The results were as follows:




To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


