



BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

ONE (1) LOT SUPPLY OF MATERIALS FOR PREVENTIVE MAINTENANCE OF GENERATOR SET LOCATED AT POWERHOUSE WITH AN ABC OF PHP126,800.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **ONE (1) LOT SUPPLY OF MATERIALS FOR PREVENTIVE MAINTENANCE OF GENERATOR SET LOCATED AT POWERHOUSE WITH AN ABC OF PHP126,800.00** on October 10 to 17, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: Gen Diesel Phil. Inc. ; Victorious General Merchandise & Services, and Oliya Trading.
