



**BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVP-26-2023**

**TWO (2) SETS UNIVERSAL SPILL KIT OIL AND CHEMICAL ETC. WITH AN ABC OF PHP244,225.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **TWO (2) SETS UNIVERSAL SPILL KIT OIL AND CHEMICAL ETC. WITH AN ABC OF PHP244,225.00** on October 10 to 17, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: Far East Fuel Corporation; Vertex Maritime International and Trading Inc., and Yang Chi Trading. None of the three (3) suppliers submitted their quotation envelope. However, Krypton International Resources Sales and Services and Joelmar Trading participated through the PhilGEPS advertisement and submitted their price quotation before the deadline and received by the BAC Secretariat;

WHEREAS, the BAC opened the sealed price quotation of supplier on October 17, 2023, at 2:00PM. The results were as follows:




