**ONE (1) LOT SUPPLY AND DELIVERY OF EIGHT (8) UNITS SWIVEL CHAIR, HIGH BACK, COLOR BLACK, LEATHER, HEAVY DUTY AND THIRTY (30) UNITS JUNIOR EXECUTIVE SWIVEL CHAIR, LOW BACK, COLOR BLACK WITH MESH AND HEAVY DUTY FOR PPA, PMO-ZAMBOANGA**

**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVP- 29 - 2018**

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation (RFQ) for the "One (1) Lot Supply and Delivery of Eight (8) Units Swivel Chair, High Back, Color Black, Leather, Heavy Duty and Thirty (30) Units Junior Executive Swivel Chair, Low Back, Color Black with Mesh and Heavy Duty for PPA, PMO-Zamboanga" with an Approved Budget for the Contract (ABC) of Php 650,000.00 from October 15-23, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to three (3) Suppliers, namely: 1) Z.C. LM Enterprises; 2) ZC Filipinas Furniture; and 3) RC Lim Marketing, all from Zamboanga City;

WHEREAS, out of the three (3) suppliers, the following suppliers submitted their price quotations, namely: 1) Z.C. LM Enterprises; 2) ZC Filipinas Furniture; 3) PC User's Shop, Zamboanga City; 4) MYZ Alta Muebles Enterprises, Antipolo City; and 5) Filcrafters, Inc., Araneta Avenue, Quezon City;

WHEREAS, the BAC opened the envelopes of the above-mentioned five (5) suppliers on October 24, 2018 at 10:00 AM and the results were as follows:

WHEREAS, since Filcrafters, Inc. was automatically disqualified, the BAC agreed to return to sender the price quotation envelope unopened;

WHEREAS, the BAC Chairperson announced that the price quotation of Z.C. LM Enterprises was Php212,100.00 as the Lowest Calculated Quotation less than the ABC of Php650,000.00 subject to the validation of documents submitted;

WHEREAS, upon verification and validation of the requirements of Z.C. LM Enterprises, all of the documentary documents were complied, except for the non-compliance on the sizes of the specifications of the above-mentioned procurement. The BAC found out that Z.C. LM Enterprises failed to comply with the bid requirements on the specifications, hence, considered not responsive and disqualified. The said supplier was immediately notified in writing and stated the grounds for its disqualification;

WHEREAS, the BAC initiated and completed the same process on the verification and validation of the requirements of the second Lowest Calculated Quotation, ZC Filipinas Furniture, in the amount of Php521,600.00 less than the ABC of Php650,000.


WHEREAS, upon verification and validation of the requirements, the BAC found out that ZC Filipinas Furniture has complied with all the requirements, hence, considered responsive;


WHEREAS, the BAC declared the Price Quotation of ZC Filipinas Furniture as the bidder with Lowest Calculated and Responsive Quotation for the One (1) Lot Supply and Delivery of Eight (8) Units Swivel Chair, High Back, Color Black, Leather, Heavy Duty and Thirty (30) Units Junior Executive Swivel Chair, Low Back, Color Black with Mesh and Heavy Duty for PPA, PMO-Zamboanga;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:


- 1) To endorse ZC Filipinas Furniture as the Supplier with the Lowest Calculated and Responsive Quotation for the One (1) Lot Supply and Delivery of Eight (8) Units Swivel Chair, High Back, Color Black, Leather, Heavy Duty and Thirty (30) Units Junior Executive Swivel Chair, Low Back, Color Black with Mesh and Heavy Duty for PPA, PMO-Zamboanga in the amount of Php521,600.00; and
- 2) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.

ADOPTED, this 25<sup>th</sup> day of October, 2018 at the PPA, PMO-Zamboanga, Zamboanga City.


