ONE (1) LOT SUPPLY OF LABOR, MATERIALS AND TOOLS FOR THE FABRICATION OF CONFERENCE TABLE, MODULAR, FOURTEEN (14) SEATERS MADE OF PLYBOARD WITH FOURTEEN (14) UNITS ERGONOMIC CHAIRS FOR USE OF PPA, PMO ZAMBOANGA WITH AN ABC OF PHP200,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Supply of Labor, Materials and Tools for the Fabrication of Conference Table, Modular, Fourteen (14) seaters made of plyboard with Fourteen (14) Units Ergonomic Chairs for Use of PPA, PMO Zamboanga with an ABC of Php200,000.00 on October 15 to 22, 2021 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) ZC Filipinas Furnitures; 2.) Bayanihan Furniture, and 3.) Curuan Home Furnishing. Out of the three (3) suppliers only one (1) submitted their price quotation namely ZC Filipinas Furniture.



To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


