

**BAC RESOLUTION DECLARING LOWEST AND RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL**

**THIRTY (30) UNITS ALUMINUM PASSENGER LUGGAGE TROLLEY WITH
INSTALLATION OF PPA LOGO WITH AN ABC OF PHP600,000.00**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **THIRTY (30) UNITS ALUMINUM PASSENGER LUGGAGE TROLLEY WITH INSTALLATION OF PPA LOGO WITH AN ABC OF PHP600,000.00** on November 3 to 10, 2023, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: ZC LM Enterprises; National Commercial, and RC Lim Marketing. Out of the three (3) suppliers, only two (2) submitted their quotation envelope before the deadline and received by the BAC Secretariat, to wit: ZC LM Enterprises, and RC Lim Marketing;

WHEREAS, the BAC opened the sealed price quotation of supplier on November 10, 2023, at 2:00PM. The results were as follows:

To declare ZC LM Enterprises as the Lowest Calculated and Responsive Quotation in the amount of Php595,500.00 for the procurement of **THIRTY (30) UNITS ALUMINUM PASSENGER LUGGAGE TROLLEY WITH INSTALLATION OF PPA LOGO WITH AN ABC OF PHP600,000.00.**
