WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the 2016 Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation (RFQ) for the "One (1) Lot Supply and Delivery of Six (6) Units Spine Board with Spider Strap, Size 48 x 7 x 186 CM and Color Orange for PPA, PMO-Zamboanga" with an Approved Budget for the Contract (ABC) of Php 60,000.00 from November 9-19, 2018, in the PPA Website, PhilGEPS Website, and PPA-PMO Bulletin Boards;

WHEREAS, RFQs were sent to three (3) Suppliers, namely: 1) Neomed Marketing; 2) Berovan Marketing, Inc.; and 3) Mediko, all from Zamboanga City;

WHEREAS, in response to the postings, out of the three (3) suppliers, only Neomed Marketing submitted the price quotation before the deadline on November 16, 2018 at 4:00 PM;

WHEREAS, the BAC opened the envelopes of the above-mentioned supplier on November 19, 2018 at 10:00 AM;

WHEREAS, the BAC Chairperson announced that the price quotation of Neomed Marketing as single supplier was Php51,000.00 less than the ABC of Php60,000.00 subject to the validation of documents submitted;


WHEREAS, upon verification and validation of the requirements of Neomed Marketing on November 22, 2018, the BAC found out that the said supplier complied with all the documentary requirements, hence, considered RESPONSIVE;


WHEREAS, the BAC declared the Price Quotation of Neomed Marketing as Single Calculated and Responsive Quotation in the amount of Php51,000.00 for the One (1) Lot Supply and Delivery of Six (6) Units Spine Board with Spider Strap, Size 48 x 7 x 186 CM and Color Orange for PPA, PMO-Zamboanga;




