## REPAIR OF POWERHOUSE BUILDING INCLUDING CFS BUILDING ELECTRICAL SYSTEM AND WALK SHED LIGHTINGS, PORT OF ZAMBOANGA, ZAMBOANGA CITY

BAC Resolution Declaring Failure Bidding and Recommending Approval

## BAC RESOLUTION NO. ZAM-PGEPCS-06-2019 / EP-04-2019 / NRP-ZBO-03-19

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the Repair of Powerhouse Building including CFS Building Electrical System and Walk Shed Led Lightings, Port of Zamboanga, Zamboanga City starting November 5, 2019 to November 29, 2019 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, in response to the said advertisements, only **ALRAF Construction & Enterprises** signified their intention to bid and purchased the bidding documents;

WHEREAS, the BAC conducted a Pre-Bid Conference on November 13, 2019 discussing among others the eligibility, technical and financial requirements of the project to be bid pursuant to Section 22 of the RA 9184;

WHEREAS, on November 21, 2019, a Supplemental/Bid Bulletin No. 1 was issued and published, both in PhilGEPS and PPA Procurement Webpage, on November 21, 2019, informing the amendment of the Approved of Budget for the Contract (ABC) from Php17,228,538.21 to Php15,283,416.82;

WHEREAS, in the receipt of Bids, **ALRAF Construction & Enterprises** submitted their bid envelope before the deadline of submission on November 29, 2019, 10:00 AM;

WHEREAS, in the opening of bids the BAC proceeded to open the bid envelope of **ALRAF Construction & Enterprises** by opening first the Technical Envelope and checked each item of the technical documents against a checklist using a non-discretionary "pass/fail" criterion. The BAC found out that the technical documents were compliant per requirements prescribed in **ITB Clause 12. Documents Comprising the Bid: Eligibility and Technical Components** and rated as "PASSED";

WHEREAS, the BAC proceeded to open the Second Bid Envelope of ALRAF Construction & Enterprises and checked its financial documents against the requirements prescribed in ITB Clause 13. Documents Comprising the Bid: Financial Component, the Chairperson announced that the submitted financial documents were compliant and the bid amount as read was Php15,230,406.24 lesser than the ABC of Php15,283,416.82. The BAC rated the financial bid as "PASSED";

WHEREAS, the BAC conducted the detailed evaluation of Bids on **December 2**, **2019**. After **ALRAF Construction & Enterprises** passed the technical and financial bids pursuant to **ITB Clause 24**. **Opening and Preliminary Examination of Bids**, to determine the Lowest Calculated Bid;

WHEREAS, in the bid evaluation, the BAC found out that the calculated bid price of **ALRAF Construction & Enterprises** in the amount of **Php15,336,082.79** were not the same with the bid price as read in the amount of **Php15,230,406.24**;







WHEREAS, the BAC declared that there was a failure of bidding since the calculated price of **ALRAF Construction & Enterprises** in the amount of **Php15,336,082.79** was more than the ABC of **Php15,283,416.82**;

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare that there was a failure of bidding for the <u>REPAIR OF POWERHOUSE</u>
  <u>BUILDING INCLUDING CFS BUILDING ELECTRICAL SYSTEM AND WALK SHED</u>
  <u>LED LIGHTINGS, PORT OF ZAMBOANGA, ZAMBOANGA CITY.</u>
- b) To recommend for approval by the Acting Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
