



ONE (1) LOT – SUPPLY, DELIVERY, AND INSTALLATION OF CONFERENCE SYSTEM-WIRED FOR PPA, PMO-ZAMBOANGA

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the 2016 Revised IRR of RA 9184 under Section 53.9-Small Value Procurement posted the Request for Quotation of "One (1) Lot – Supply, Delivery, and Installation of Conference System-Wired for PPA, PMO-Zamboanga" with an Approved Budget for the Contract (ABC) of Php150,000.00 from November 21-29, 2018, in the PPA Website, PhilGEPS Website, and in the PMO Bulletin Boards;

WHEREAS, the BAC sent Request for Quotations (RFQs) to four (4) suppliers, namely: 1) JVS Audio System; 2) Z.C. Paperline and Computer Stationers; 3) RC Lim Marketing; and 4) Electron Comtronics and Service Center;

WHEREAS, in response to the postings, of the four (4) suppliers, only two (2) suppliers, JVS Audio System and Electron Comtronics and Service Center submitted the price quotation;

WHEREAS, the BAC opened the sealed price quotation of the said suppliers on December 3, 2018 at 10:00 AM. The results were detailed below:

WHEREAS, the BAC declared JVS Audio System as the supplier with the Lowest Price Quotation in the amount of Php 129,600.00 less than the ABC of Php 150,000.00 subject to the validation of the bid documents submitted;

WHEREAS, upon validation of the documents on December 5, 2018 for the Lowest Price Quotation, JVS Audio System, the result of the validation was RESPONSIVE for being eligible and compliant with all the documentary requirements of the BAC;

NOW, THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

- a) To endorse JVS Audio System as the Supplier with the Lowest Calculated and Responsive Quotation in the amount of Php 129,600.00 for the "One (1) Lot – Supply, Delivery, and Installation of Conference System-Wired for PPA, PMO-Zamboanga"; and
- b) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.
