**BAC RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING APPROVAL**

**BAC RESOLUTION NO. SVP-08-2024**

**Five (5) Units Lateral File Cabinets for Official use of PPA, PMO Zamboanga, Zamboanga City with an ABC of Php95,000.00.**

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the **Five (5) Units Lateral File Cabinets for Official use of PPA, PMO Zamboanga, Zamboanga City with an ABC of Php95,000.00** on March 14 to 21, 2024, in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards;

WHEREAS, the procurement is conducted through Negotiated Procurement-Small Value Procurement (Sec. 53.9) and the amount does not exceed the threshold prescribed in Annex H of the IRR;

WHEREAS, the BAC sent Request for Quotation (RFQ) to three (3) suppliers, namely: ZC LM Enterprises; National Commercial, and RC Lim Marketing. Out of the three (3) suppliers, only two (2) submitted their quotation envelope before the deadline and received by the BAC Secretariat, to wit: ZC LM Enterprises, and RC Lim Marketing;

WHEREAS, the BAC opened the sealed price quotation of supplier on March 21, 2024, at 2:00PM. The results were as follows:


To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.


