**"A RESOLUTION DECLARING A.I. YU BUILDERS AND ENTERPRISES**  
**AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER AND RECOMMENDING**  
**AWARD FOR THE PROJECT CONSTRUCTION OF PASSENGER TERMINAL BUILDING**  
**AND PORT LIGHTING SYSTEM, PORT OF GLAN, GLAN, SARANGANI PROVINCE"**

**WHEREAS**, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Proposed Construction of Passenger Terminal Building and Port Lighting System, Port of Glan, Glan, Sarangani Province with an Approved Budget for the Contract (ABC) of **Seven Million Seven Hundred Ninety One Thousand One Hundred Fifty Three Pesos and 40/100 (Php7,791,153.40)** only;

**WHEREAS**, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

**WHEREAS**, the said Invitation to Bid was also published in the Philippine Star;

**WHEREAS**, in response to the said publication and posting requirement, two (2) bidders procured the bidding documents namely A.I. Yu Builders and Enterprises and FFJJ Construction;

**WHEREAS**, two (2) bidders successfully dropped its bid on time;

**WHEREAS**, IN Resolution No. 06 Series of 2015 dated July 21, 2015, the BAC-EP declared A.I Yu Builders and Enterprises as Single Calculated Bidder;

**WHEREAS**, a corresponding post qualification was conducted by the Technical Working Group (TWG) of the BAC-EP on July 28 to July 29, 2015;

**WHEREAS**, the TWG, during the August 3, 2015 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by A.I. Yu Builders and Enterprises;

**NOW, THEREFORE**, We the members of the BAC-EP **RESOLVED** as it is hereby **RESOLVED**:

- a) To declare A.I. Yu Builders and Enterprises as the Single Calculated and Responsive Bidder for the project Proposed Construction of Passenger

Terminal Building and Port Lighting System, Port of Glan, Glan, Sarangani Province with the bid amount of Seven Million Seven Hundred Eighty Thousand One Hundred Seventy and 58/100 Pesos (**Php** 7,780,170.58);

- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award..
