THIS AGREEMENT, made this _____ day of 26 AUG 2018,
_____ between **PHILIPPINE PORTS AUTHORITY, PORT
MANAGEMENT OFFICE - TACLOBAN, Tacloban City** (hereinafter called
the "Entity") and **JUPA CONSTRUCTION**, (hereinafter called the
"Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Repair of

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
