CONTRACT AGREEMENT
FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF LED
SOLAR STREET/ROAD LIGHTS FOR PORT MANAGEMENT OFFICES

This Contract made and entered into this JAN 11 2021 day of _____ 2021 in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), herein referred to as ENTITY, is a government instrumentality created under Presidential Decree No. 857, as amended, with principal office address at PPA Bldg., Bonifacio Drive, South Harbor, Port Area, Manila, represented by **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, as contained in Secretary's Certificate dated 02 November 2015, copy of which is hereto attached as **Annex A**.

and

MINDANAO LABORATORY SERVICES, duly organized and existing under the Philippine laws, with principal office address at Davao St., Aluba, Macasandig, Cagayan de Oro City, represented herein by its General Manager, **MANUEL B. RODAJE, JR.**, duly authorized for this purpose, as shown in Special Power of Attorney dated 8 July 2020, copy of which is hereto attached as **Annex B**.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Supply, Delivery, Installation, Testing and Commissioning of LED Solar Street/Road Lights for Port Management Offices, with an approved Budget for the Contract (ABC) of Php **300,000,000.00** and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of **(TWO HUNDRED NINETY SEVEN MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (Php 297,750,000.00))**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any



- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e. g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **TWO HUNDRED NINETY SEVEN MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (Php 297,750,000.00)** or such other sums as may be ascertained, Mindanao Laboratory Services agrees for the Supply, Delivery, Installation, Testing and Commissioning of LED Solar Street/Road Lights for Port Management Offices in accordance with its Bid.
 4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
