CONTRACT AGREEMENT

FOR THE PROCUREMENT OF PEST CONTROL SERVICES FOR PPA HEAD OFFICE, MOTORPOOL, PPATI, GAD CENTER AND RECORDS STORAGE FACILITY

This Agreement made and entered into this FEB 1 4 2024 day Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area Manila, represented herein by its General Manager, JAY DANIEL R. SANTIAGO, duly authorized for this purpose under Board Resolution No. 2466, Series of 2015 as contained in Secretary's Certificate dated 02 November 2015, a copy of which is attached as Annex A.

- and -

DECIMAL PEST CONTROL SERVICES, herein referred to as SUPPLIER and/or WINNING BIDDER, a business organized and existing under Philippine laws, with business address at Unit D, Block 2 Lot 3, Hobart Village, Zabarte Road, Novaliches, Quezon City, represented herein by its Proprietor, ERNIE B. MANEJA, duly authorized for this purpose, as shown in Department of Trade and Industry (DTI) Certificate of Registration No. 4705521, copy of which is hereto attached as Annex B.

ANTECEDENTS:

In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board and sent invitation letters to three (3) certifying bodies, a Request for Proposal (RFP) for the Procurement of of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility {Under Negotiated Procurement (Two-Failed Biddings)}, with an Approved Budget for the Contract (ABC) of Php 2,470,000.00;

In response to the invitation, five (5) certifying bodies submitted its proposal for the foregoing project;

During the Negotiation held on 18 September 2023, the prospective suppliers were given the opportunity to negotiate and discuss the technical and financial requirements of the project;

In the evaluation of the Technical and Financial requirements, only DECIMAL PEST **CONTROL SERVICES** passed the Technical and Financial requirements;

Pursuant to Head Office BAC Resolution No. 003-2024 Series of 2024, award of contract was made to DECIMAL PEST CONTROL SERVICES in a Notice of Award dated 01 January 2024, in the amount of ONE MILLION SEVEN HUNDRED NINETY SEVEN THOUSAND FIVE HUNDRED EIGHTY SEVEN PESOS AND 42/100 (Php 1,797,587.42), after submission of the required documents within the prescribed period and compliance to the conditions stipulated in the IRR;

NOW, THEREFORE, for and in consideration of the foregoing premises and the mutual stipulations herein contained, PPA and DECIMAL PEST CONTROL SERVICES have agreed, as follows:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the attached Contract Documents.
- 2. The following documents shall form part of this Contract:

 - A.2 Terms of Reference (Annex D)
 - A.3 Technical Specifications (Annex E)
 - B. Technical and Financial Proposals (Annex F)

 - D. Notice of Award of Contract with DECIMAL PEST CONTROL SERVICES Conforme thereto (Annex H)
 - E. Other contract documents that may be required by existing laws and PPA:
 - E.1 Certificate of Availability of Funds (Annex I)
 - E.2 Summary of Evaluation of Technical and Financial Documents (Annex J)
 - E.3 Resolution of Award (Annex K)
- 3. In consideration of the sum of ONE MILLION SEVEN HUNDRED NINETY SEVEN THOUSAND FIVE HUNDRED EIGHTY SEVEN PESOS AND 42/100 (Php 1,797,587.42) or such other sums as may be ascertained, DECIMAL PEST CONTROL SERVICES agrees to the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, in accordance with its Bid.
- 4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. In execution of its Works, DECIMAL PEST CONTROL SERVICES shall likewise hold PPA free and harmless from any liability due to actions, damages, or accident it may cause in the course thereof.
- 6. The failure of PPA to insist upon a strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any of the rights or remedies that it may have, nor shall it be construed as a waiver of any subsequent breach or default of its terms, conditions and covenants which shall continue to be in full force and effect. Silence on the part of PPA shall not be considered as condonation or waiver of any breach or default by DECIMAL PEST CONTROL SERVICES of any covenant or condition herein provided. No waiver by PPA of its rights under this Contract shall be deemed to have been made unless expressly made in writing and signed by its duly authorized representative.
