AMENDMENT TO CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This Amendment to Contract is entered into by and between:

PHILIPPINE PORTS AUTHORITY, a government instrumentality created under Presidential Decree 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its General Manager, **JAY DANIEL R. SANTIAGO**, and hereinafter referred to as "PPA";

BOSTON HOME, INCORPORATED (TIN 004-608-983-000), private corporations duly organized and existing under the laws of the Republic of the Philippines, with office address at 168 Apo St., Sta. Mesa Heights, Quezon City, represented in this act by duly Authorized Representative, **BERNARD T. TIONGSON**, as evidenced by its Secretary's Certificate dated 28 November 2017, a copy of which is hereto attached as Annex "A" and made an integral part of this Contract, and hereinafter referred to as "SUPPLIER".

RECITALS:


WHEREAS, the parties entered into a contract on 06 April 2018, with a contract price in the amount of ONE HUNDRED SIXTY-SEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS ONLY (P167,760,000.00), hereto attached as Annex "B";



WHEREAS, Section VII of the Terms of Reference as per bidding documents provides for a pre-delivery inspection, all expenses of which shall be for the account of the Supplier, to wit:

xxx

VII. OTHER TERMS AND CONDITIONS

1. **Pre-delivery Inspection.** A pre-delivery inspection in the place of manufacture, including the manufacturing line of the machines shall be done by the PPA, through its representatives it has chosen for the purpose. All travel and accommodation expenses for such inspection shall be for the account of the Supplier.

WHEREAS, the winning bidder submitted its financial bid, taking into consideration the cost of pre-delivery inspection;

WHEREAS, Sec. 16.3 of the General Conditions of Contract (GCC) states that the PPA as the Procuring Entity, or its designated representative/s shall be entitled to attend the tests and/or inspections provided that the Procuring Entity shall bear all of its own costs and expenses incurred in connection with such attendance including, but not limited to, all traveling and board and lodging expenses;

WHEREAS, having considered the cost of travel and accommodation expenses of the representatives of PPA, the parties agree to deduct said amount from the contract price;

NOW, THEREFORE, for and in consideration of the foregoing, the parties hereby stipulate and agree that:

Since all expenses for travel and accommodation in connection with the pre-delivery inspection shall be for the account of the PPA, the total amount of P200,000.00 for each representative is hereby allotted and shall be deducted from the contract price, thus:

P200,000.00 x 3	600,000.00


