PHILIPPINE PORTS AUTHORITY (PPA), a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA Building, Bonifacio Drive, South Harbor, Port Area, Manila, represented herein by its General Manager, JAY DANIEL R. SANTIAGO, duly authorized for this purpose under Board Resolution No. 2445, Series of 2015, attached herein as Annex A.

- and -

JEJOR'S CONSTRUCTION CORPORATION, duly organized and existing in accordance with Philippine laws, with principal office address at Quiboro Poblacion, Mambajao, Camiguin, represented herein by its Authorized Representative, JORDAN G. TIU, duly authorized for this purpose as shown in Secretary's Certificate dated 22 April 2022, attached herein as Annex B.

WHEREAS, the Entity is desirous that the Contractor execute the Construction of Port Operations Building, Port of Benoni, Brgy. Benoni, Mahinog, Camiguin, with an approved Budget for the Contract (ABC) of Php 159,865,758.22 and the Entity has accepted the Bid for ONE HUNDRED FIFTY NINE MILLION TWO HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED SIXTY TWO AND 64/100 PESOS (Php 159,295,862.64) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
  - a. Philippine Bidding Documents (PBDs);
    - i. Drawings/Plans;
    - ii. Specifications;
    - iii. Bill of Quantities;
    - iv. General and Special Conditions of Contract:
    - Supplemental or Bid Bulletins, if any

In consideration of the sum of ONE HUNDRED FIFTY NINE MILLION TWO HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED SIXTY TWO AND 64/100 PESOS (Php 159,295,862.64) or such other sums as may be ascertained, JEJOR'S CONSTRUCTION CORPORATION agrees to execute the Construction of Port Operations Building, Port of Benoni, Brgy. Benoni, Mahinog, Camiguin, in accordance with its Bid.
- The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- In execution of its Works, JEJOR'S CONSTRUCTION CORPORATION shall likewise hold PPA free and harmless from any liability due to actions, damages, or accident it may cause in the course thereof.
- 6. The failure of PPA to insist upon a strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any of the rights or remedies that it may have, nor shall it be construed as a waiver of any subsequent breach or default of its terms, conditions and covenants which shall continue to be in full force and effect. Silence on the part of PPA shall not be considered as condonation or waiver of any breach or default by JEJOR'S CONSTRUCTION CORPORATION of any covenant or condition herein provided. No waiver by PPA of its rights under this Contract shall be deemed to have been made unless expressly made in writing and signed by its duly authorized representative.
