**ANTECEDENTS:**


In accordance with Republic Act No. 9184 and its 2016 Revised Implementing Rules and Regulations (IRR), PPA advertised and posted on the PPA website and PhilGEPS, as well as on its bulletin board, a Request for Proposal for the Consultancy Services for the Hydrographic and Topographic Survey for the Construction of Coastal Port, Brgy. Pugad, Hagonoy, Bulacan (DOTr Project downloaded to PPA for Implementation);

The Request for Proposal was likewise sent to at least three (3) consultants of known qualification, however, only the CONSULTANT responded and submitted its proposal;


After the opening of the submitted Financial Proposal of the CONSULTANT, an Abstract of Rating was prepared and the CONSULTANT was determined as having the Single Rated and Responsive Proposal, in the amount of **TWO HUNDRED THREE THOUSAND PESOS ( Php 203,000.00)**;

Pursuant to Head Office BAC Resolution No. 034-2020 Series of 2020, award of contract was made to the CONSULTANT in a Notice of Award dated 13 March 2020, in the amount of **TWO HUNDRED THREE THOUSAND PESOS ( Php 203,000.00)**;



4. In consideration of the execution and completion of the Works and remedying any defects therein, PPA commits to pay the Contract Price or such other sum as may become payable under the provisions of this Contract and Contract Documents.
5. This Contract shall become effective after the same shall have been signed by the Parties hereof.
