SANTIAGO, duly authorized for this purpose under Board Resolution No. 2445, Series of 2015, attached herein as Annex A.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;

 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any

In consideration of the sum of FIVE HUNDRED SIXTY EIGHT MILLION SEVEN HUNDRED SIXTY FIVE THOUSAND THREE HUNDRED NINETY FOUR AND 73/100 (Php 568,765,394.73) or such other sums as may be ascertained, MAMSAR CONSTRUCTION & INDUSTRIAL CORPORATION/SILVER DRAGON CONSTRUCTION & LUMBER & GLASS SUPPLY, INC./JV agrees to execute the Banago Port Improvement Project, Port of Banago, Bacolod City, Negros Occidental, in accordance with its Bid.
- 4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- In execution of its Works, MAMSAR CONSTRUCTION & INDUSTRIAL CORPORATION/SILVER DRAGON CONSTRUCTION & LUMBER & GLASS SUPPLY, INC./JV shall likewise hold PPA free and harmless from any liability due to actions, damages, or accident it may cause in the course thereof.

The failure of PPA to insist upon a strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any of the rights or remedies that it may have, nor shall it be construed as a waiver of any subsequent breach or default of its terms, conditions and covenants which shall continue to be in full force and effect. Silence on the part of PPA shall not be considered as condonation or waiver of any breach or default by MAMSAR CONSTRUCTION & INDUSTRIAL CORPORATION/SILVER DRAGON CONSTRUCTION & LUMBER & GLASS SUPPLY, INC./JV of any covenant or condition herein provided. No waiver by PPA of its rights under this Contract shall be deemed to have been made unless expressly made in writing and signed by its duly authorized representative.
