CONTRACT AGREEMENT
FOR THE PROCUREMENT OF ADMINISTRATIVE SUPPORT MANPOWER SERVICES FOR
PPA PORT MANAGEMENT OFFICES AND PROJECTS (LUZON CLUSTER)

This Agreement made and entered into this ~~SEP 15~~ SEP 15 day of _____ 2021 in Manila, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY (PPA), herein referred to as ENTITY, is a government instrumentality created under Presidential Decree No. 857, as amended, with principal office address at PPA Bldg., Bonifacio Drive, South Harbor, Port Area, Manila, represented by **JAY DANIEL R. SANTIAGO**, duly authorized for this purpose under Board Resolution No. 2466, as contained in Secretary's Certificate dated 02 November 2015, copy of which is hereto attached as **Annex A**.

and

DBP SERVICE CORPORATION, duly organized and existing under Philippine laws, with principal office address at Units 2nd Floor, Executive Bldg. Center, Gil Puyat Ave., Makati City, represented herein by its Acting President, **RAUL LUIS D. MANALIGOD**, duly authorized for this purpose, as shown in Secretary's Certificate dated 16 August 2021, copy of which is hereto attached as **Annex B**.

WHEREAS, the Entity invited Bids for certain services, particularly the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Luzon Cluster), with an approved Budget for the Contract (ABC) of Php **252,625,710.28** and has accepted a Bid by **DBP SERVICE CORPORATION** for those services in the sum of **TWO HUNDRED FIFTY TWO MILLION THREE HUNDRED EIGHTY FOUR THOUSAND ONE HUNDRED THIRTY SIX PESOS AND 56/100 (Php 252,384,136.56)**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration of the sum of **TWO HUNDRED FIFTY TWO MILLION THREE HUNDRED EIGHTY FOUR THOUSAND ONE HUNDRED THIRTY SIX PESOS AND 56/100 (Php 252,384,136.56)** or such other sums as may be ascertained, **DBP SERVICE CORPORATION** agrees to the Procurement of Administrative Support Manpower Services for PPA Port Management Offices and Projects (Luzon Cluster), in accordance with its Bid.

4. The Philippine Ports Authority agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. In execution of its Works, **DBP SERVICE CORPORATION** shall likewise hold PPA free and harmless from any liability due to actions, damages, or accident it may cause in the course thereof.

6. The failure of PPA to insist upon a strict performance of any of the terms, conditions and covenants hereof shall not be deemed a relinquishment or waiver of any of the rights or remedies that it may have, nor shall it be construed as a waiver of any subsequent breach or default of its terms, conditions and covenants which shall continue to be in full force and effect. Silence on the part of PPA shall not be considered as condonation or waiver of any breach or default by **DBP SERVICE CORPORATION** of any covenant or condition herein provided. No waiver by PPA of its rights under this Contract shall be deemed to have been made unless expressly made in writing and signed by its duly authorized representative.
