CONTRACT FOR THE SUPPLY AND DELIVERY OF PURIFIED DRINKING WATER FOR TMOs (TABLAS) (PPAPMOB-GDS-2026-002)

This CONTRACT executed on the MAR 12 2026 2026 by and between:

Philippine Ports Authority – PMO Batangas, a government instrumentality of the Republic of the Philippines, hereinafter called “the Entity”;

-and-

Autorun Purified Water Station a company duly organized and existing under the laws of Philippines, with principal office at Anahao, Odiongan, Romblon hereinafter called “the Supplier”.

WHEREAS, the Entity invited Bids for certain goods and services, particularly for the **Supply and Delivery of Purified Drinking Water for TMOs (Tablas)**;

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **Fifty-Two Thousand Five Hundred Pesos (Php 52,500.00)**, hereinafter referred to as the “Contract Price.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Terms of Reference, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz.:
 - a. Philippine Bidding Documents (PBD);
 - *For Procurement of Goods*
 - i. Terms of Reference;
 - ii. Request for Quotation;
 - iii. Instruction to Bidders;
 - iv. Supplemental or Bid Bulletins, if any;
 - v. Other contract documents that may be required by existing laws and/or the Entity.
 - b. Winning bidder's bid/quotation, including the Eligibility, Technical, Financial, and all other documents or statements submitted;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's Conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.
3. In consideration of the Contract Price of **Fifty-Two Thousand Five Hundred Pesos (Php 52,500.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the Supplier agrees to deliver and perform the items and related services for the **Supply and Delivery of Purified Drinking Water for TMOs (Tablas)** described herein in accordance with the terms and conditions of the project.
