**Contract Agreement for the
Upkeeping of Green Areas, Roads, Yards and Pavement at PPA PMO
Batangas for the Months of August 2024 to September 2024**

This Contract made and entered into this _____ day of AUG 08 2024 2024 in Batangas, Philippines, by and between:

PHILIPPINE PORTS AUTHORITY, PMO-BATANGAS herein referred to as ENTITY is a government instrumentality created under Presidential Decree No. 857, as amended, with principal office at PPA New Administration Building, Diversion Rd., Calicanto, Batangas City, represented herein by its Port Manager, **JOSELITO O SINOCRUZ**;

- and -

STA CRUZ CONSTRUCTION AND GENERAL SERVICES, herein referred to as SUPPLIER, with office address at Brgy Soloc, Lobo, Batangas represented herein by its Authorized Representative **MARIA C UNTALAN**, duly authorized for this purpose, as shown with Department of Trade and Industry with Certificate No. 3777407.

WHEREAS, the Entity invited Bids for the project **Upkeeping of Green Areas, Roads, Yards and Pavement at PPA PMO Batangas for the Month of August 2024 to September 2024** with an Approved Budget for the Contract (ABC) of **Nine Hundred Seven Thousand Five Hundred Nineteen Pesos and 17/100 (Php 907,519.17)**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Terms of Reference hereinafter referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Terms of Reference;
 - ii. Request for Quotation;
 - iii. Supplemental or Bid Bulletins, if any;
 - ii. Supplier's quotation, including all other documents or statements submitted;
 - iii. Quotation form, including all the documents/statements contained in the as annexes, and all other documents submitted;
 - iv. Notice of Award of Contract and the Supplier's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the ENTITY. Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution shall likewise form part of the Contract.
3. In consideration for the sum of **Nine Hundred Seven Thousand Three Hundred Pesos (PHP 907,300.00)**, Sta. Cruz Construction and General Services agrees to accomplish the contract in accordance with its Quotation.
4. The Philippine Ports Authority – PMO Batangas agrees to pay the above-mentioned sum in accordance with the Terms of Reference.
