KNOW ALL MEN BY THESE PRESENTS:

This Agreement made this 21 day of JUN, 2019, 2019 in the City of QUEZON CITY, Philippines, between **PHILIPPINE PORTS AUTHORITY, PMO-PALAWAN**, a government instrumentality with corporate powers attached to the Department of Transportation (DOTr) created and existing under and by virtue of Presidential Decree No. 857, as amended, with office at Quezon Street, Barangay Bagong Pag-Asa, Port Area, Puerto Princesa City, Palawan represented herein by its **Acting Port Manager, ELIZALDE M. ULSON**, hereinafter referred to as the "PPA".

**H.O. NOVELOSO SURVEYING**, with principal office at San Pedro, Ili, Alcala, Pangasinan Province, represented herein by its **GE/Consultant, HIPOLITO O. NOVELOSO**, hereinafter called the "Contractor/Consultant".

Whereas, the PPA is desirous that the consultant execute the **Proposed Hydrographic and Topographic Survey of El Nido Port, El Nido, Palawan**, hereinafter called "the works" and the PPA has accepted the Price Quotation for **One Hundred Ninety-Four Thousand Nine Hundred Ninety-Nine Pesos and 96/100 (Php 194,999.96)** by the Consultant for the execution and completion of such Works and remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this agreement, word and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) Price Quotation
  - (b) Notice of Award of Contract/Consultancy and the Consultant's conforme thereto;
  - (c) Other contract documents that may be required by existing laws and/or the Entity.


1. Certified True Copy of Current Mayor's Business Permit

  3. BIR Certificate of Registration/TIN
  4. Latest Income Tax and Business Tax Returns and taxes paid through BIR Electronics Filing and Payment System (eFPS)
  5. PhilGEPS Registration Number
  6. Certificate of Registration of Total Surveying Instrument
3. In consideration of the payments to be made by the PPA to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the PPA execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
  4. The PPA hereby covenants to pay the Consultant in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price of such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
  5. The Consultant shall complete the works in accordance with the Price Quotation Documents within **Twenty (20) Calendar Days**.
  6. Should the Consultant refuse or fails to satisfactorily complete the works within the specified completion period inclusive of granted time extension, if any, the Consultant shall be liable for damages for the delay and shall pay the PPA Liquidated damages in accordance with Annex "E" Section 8 of the Revised Implementing Rules and Regulations of RA 9184.
