THIS AGREEMENT, made this _____ day of JAN 12 2017, 20__ between:

PHILIPPINE PORTS AUTHORITY (PPA), with local office at Brgy. Loboc, La Paz, Iloilo City, represented herein by its Port Manager, **JOSE CESARIO O. BAUTISTA**, herein referred to as PPA

and

STA. CRUZ CONSTRUCTION & GENERAL SERVCIES, with business and office address at **Poblacion, Lobo, Batangas**, represented herein by its Authorized Representative, **PANCHO C. UNTALAN**, hereinafter referred to as CONTRACTOR.

WHEREAS, PPA is desirous that the Contractor execute the "**Repair/Replacement of Solar Streetlighting System and Fixtures at Port of Culasi, Roxas City**" and the PPA has accepted the Bid for **Ten Million, Seven Hundred Forty Thousand, Thirty-Six Pesos (P10,740,036.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity.
