**PROVISION OF TEMPORARY TERMINAL OFFICE AND PASSENGER
TERMINAL SHED AT PORT OF CULASI, ROXAS CITY**

THIS AGREEMENT, made this _____ day of NOV 21 2016, 20____ between:

PHILIPPINE PORTS AUTHORITY (PPA), with local office at Brgy. Loboc, La Paz, Iloilo City, represented herein by its Port Manager, ROSENDA G. SUMAGAYSAY, herein referred to as PPA

and

VANNIE CONSTRUCTION AND SUPPLY, with business and office address at **PHASE II, ROSAL STREET, ALTA TIERRA VILLAGE, JARO, ILOILO CITY** represented herein by its Proprietor, EVANGELINE L. ANDRADE, hereinafter referred to as **CONTRACTOR**.

WHEREAS, PPA is desirous that the Contractor execute the "Provision of Temporary Terminal Office and Passenger Terminal Shed at Port of Culasi, Roxas City" and the PPA has accepted the Bid for **Three Million, Seven Hundred Eighty-One Thousand, Seven Hundred Eighty-Five Pesos Only (P 3,781,785.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the PPA to the EVANGELINE L. ANDRADE hereinafter mentioned, the Contractor hereby covenants with the PPA to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The PPA hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
