REPAIR/REPLACEMENT OF SOLAR STREETLIGHTING SYSTEM AND FIXTURES AT FORT SAN PEDRO, ILOILO CITY

THIS AGREEMENT, made this ____ day of DEC 05 2016, 20__ between:

PHILIPPINE PORTS AUTHORITY (PPA), with local office at Brgy. Loboc, La Paz, Iloilo City, represented herein by its Port Manager, ROSENDA G. SUMAGAYSAY, herein referred to as PPA

and

STA. CRUZ CONSTRUCTION AND GENERAL SERVICES, with business and office address at Poblacion, Lobo, Batangas represented herein by its Proprietor, PANCHO C. UNTALAN, hereinafter referred to as CONTRACTOR.

WHEREAS, PPA is desirous that the Contractor execute the “Repair/Replacement of Solar Streetlighting System and Fixtures at Fort San Pedro, Iloilo City” and the PPA has accepted the Bid for **Thirteen Million Two Hundred Fifty Four Thousand, Three Hundred Fourteen Pesos Only (P 13,254,314.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity.






