



## CONTRACT AGREEMENT

**“SUPPLY, DELIVERY AND INSTALLATION OF FOURTEEN (14) BRAND NEW AIRCONDITIONING UNITS, 2HP WINDOW TYPE AND NINE (9) BRAND NEW AIRCONDITIONING UNITS, 3-TONNER FLOOR MOUNTED, 230V, 1-PHASE (INVERTER TYPE)”**

THIS AGREEMENT entered into by and between:

PHILIPPINE PORTS AUTHORITY (PPA), with local office at Barangay Loboc, La Paz, Iloilo City, Philippines, represented herein by its Acting Port Manager, **EDUARDO P. GOLES** hereinafter referred to as Procuring Entity

- and -

**EMCOR, INC.**, with business and office address at JVR Bldg., Diversion Road, Mandurriao, Iloilo City represented herein by its Sales Supervisor, **MAE ANN G. OLIVEROS** hereinafter referred to as the Supplier:

WHEREAS, the Procuring Entity invited Bids for the **“SUPPLY, DELIVERY AND INSTALLATION OF FOURTEEN (14) BRAND NEW AIRCONDITIONING UNITS, 2HP WINDOW TYPE AND NINE (9) BRAND NEW AIRCONDITIONING UNITS, 3-TONNER FLOOR MOUNTED, 230V, 1-PHASE (INVERTER TYPE)”** and has accepted a Bid by the Supplier for the supply of those goods in the sum of **ONE MILLION EIGHT HUNDRED FORTY-FIVE THOUSAND EIGHT HUNDRED TWENTY-NINE PESOS ONLY (Php 1,845,829.00)** hereinafter called “the Contract Price”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1) In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2) The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a) Bid Form and the Price Schedule submitted by the Bidder;
  - b) the Schedule of Requirements;
  - c) the Technical Specifications;
  - d) the General Conditions of Contract;
  - e) the Special Conditions of Contract; and
  - f) the Procuring Entity’s Notification of Award.
- 3) In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4) The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


