

and

F. GURREA CONSTRUCTION INC., with business and office address at **Q. ABETO STREET, MANDURRIO, ILOILO CITY** represented herein by its Proprietor, **ENGR. JANNETTE G. ANSINO**, hereinafter referred to as CONTRACTOR.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
