PHILIPPINE PORTS AUTHORITY (PPA), with local office at Brgy. Loboc, La Paz, Iloilo City, represented herein by its Acting Port Manager, EDUARDO P. GOLES, herein referred to as PPA

and

KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION, with business and office address at **GREENHEIGHTS, DIVERSION ROAD, BUHANGIN, DAVAO CITY** represented herein by its Proprietor, ENGR. ARSENIO B. GROSPE, hereinafter referred to as CONTRACTOR.

WHEREAS, PPA is desirous that the Contractor execute the "Repair/Replacement of Damaged Fendering System at Lapuz Side of Iloilo River Wharf, Port of Iloilo, Iloilo City" and the PPA has accepted the Bid for Twenty-Nine Million, One Hundred Fifty Thousand, One Hundred Five Pesos and 44/100 (P29, 150,105.44) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity.




