REPAIR OF DRAINAGE SYSTEM AT ICPC, ILOILO CITY

THIS AGREEMENT, made this _____ day of JUL 24 2018, 20__ between:

PHILIPPINE PORTS AUTHORITY (PPA), with local office at Brgy. Loboc, La Paz, Iloilo City, represented herein by its Acting Port Manager, **EDUARDO P. GOLES**, herein referred to as PPA

and

E.M PAULE CONSTRUCTION & TRADING INC, with business and office address at **ILOILO SATELLITE OFFICE BRGY. PANGSANGA-AN, PAVIA, ILOILO** represented herein by its Proprietor, **ENGR.PIOLITO L. GALACAN**, hereinafter referred to as **CONTRACTOR**.

WHEREAS, PPA is desirous that the Contractor execute the “**Repair of Drainage System at ICPC, Iloilo City**” and the PPA has accepted the Bid for **Four Million Nine Hundred Seventeen Thousand Seven Hundred Seventy-Three Pesos and 96/100 (P 4,917,773.96)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity.
