REMOVAL OF DAMAGED STEEL PILE FENDER

THIS AGREEMENT, made this _____ day of _____, _____ between **PHILIPPINE PORTS AUTHORITY, Port Management Office of Tacloban, Tacloban City** (hereinafter called the "Entity") and **Big J Steel Const. Corp. Mezzanine Flr. Fascon Bldg. # 265 Roosevelt Ave. San Antonio, SFDM, Quezon City, Metro Manila** (hereinafter called the "Contractor")

WHEREAS, the Entity is desirous that the Contractor execute **Removal of Damaged Steel Pile Fender** (hereinafter called "the Works") and the Entity has accepted the Bid for **SIX HUNDRED FOURTY SIX THOUSAND EIGHT HUNDRED FOURTY EIGHT PESOS ONLY (Ph 646,848.00)** by the Contractor for the execution and completion of such Works within Twelve (12) Calendar Days and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Request for Quotation (RFQ)
 - (b) Drawings/Plans;
 - (c) Invitation to Bid;
 - (d) Specifications
 - (e) Addenda and/or Supplemental/Bid Bulletins, if any.
 - (f) Abstract of Quotation
 - (g) Notice of Award of Contract and the Bidder's conforme thereto
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
