**REPAIR OF DAMAGED PORTION OF RECLAMATION DUE TO TYPHOON "PAOLO" LAST OCTOBER 21,2017**

THIS AGREEMENT, made this NOV 13 2018 day of \_\_\_\_\_, between **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE - EASTERN LEYTE/SAMAR, Tacloban City** (hereinafter called the "Entity") and **RONNIE V. DEL ROSARIO , Roman Highway, Puting Buhangin, Orion, Bataan, herinafter called the "Contractor"**

WHEREAS, the Entity is desirous that the Contractor execute **Repair Of Damaged Portion of Reclamation due to Typhoon " PAOLO" last Oct. 21,2017, Port of Manguino-o, Calbayog City, Samar (NRP-ELS-02-18)** (hereinafter called "the Works") and the Entity has accepted the Bid for **Six Million Nine Hundred Seventy Thousand Three Hundred Seventy One and 41/100 Pesos (P6,970,371.41)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (d) Winning Bidder's Bid, including the Eligibility requirements, Technical and Financial Proposals, and all the documents/statements submitted;
  - (e) Performance Security;
  - (f) Credit line issued by a licensed bank, if any;
  - (g) Notice of Award of Contract and the Bidder's conforme thereto;
  - (h) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Bidding Documents.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works


