REPAIR OF DEPRESSED DAMAGED CONCRETE PAVING BLOCKS AT BERTH 4 & 5 PORT OF TACLOBAN, TACLOBAN CITY

THIS AGREEMENT, made this _____day of _____, ____ between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE - EASTERN LEYTE/SAMAR, Tacloban City (hereinafter called the "Entity") and EDTAHA BUILDERS INCORPORATED, Ozamis City, Misamis Oriental (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute Repair of Damaged Depressed Concrete Paving Blocks at Berth 4 & 5, Port of Tacloban, Tacloban City (NRP-ELS 05-18) (hereinafter called "the Works") and the Entity has accepted the Bid for Ten Million Four Hundred Forty-Nine Thousand Nine Hundred Eighteen and 71/100 Pesos (\$\bigsep\$10,449,918.71) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Conctract Agreement;
 - (b) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (c) Bidding Documents;
 - (d) Winning Bidder's Bid, including the Eligibility requirements, Technical and Financial Proposals, and all the documents/statements submitted;
 - (e) Performance Security;
 - (f) Credit line issued by a licensed bank, if any;
 - (g) Notice of Award of Contract and the Bidder's conforme thereto;
 - (h) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
