KNOW ALL MEN BY THESE PRESENTS:


THIS AGREEMENT, made this 4<sup>th</sup> day of October, 2023 between **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE – NEGROS OCCIDENTAL/BANAGO/BACOLOD, Port of Banago, Bacolod City** hereinafter called the “Entity”) and **RDR1 BUILDERS INCORPORATED** (hereinafter called the “Contractor”).

WHEREAS, the Entity is desirous that the Contractor execute **MAINTENANCE OF PERIMETER FENCE AND PUBLIC TOILET, PORT OF DANAO, ESCALANTE CITY, NEGROS OCCIDENTAL TO PPA, PMO-NEGROS OCCIDENTAL (CW-SV-05-23)** hereinafter called “the Works”) and the Entity has accepted the Bid for **NINE HUNDRED SIXTY SIX THOUSAND TREE HUNDRED SIXTY SIX AND 08/100 PESOS (P966,366.08)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


