



CONTRACT AGREEMENT

THIS AGREEMENT made this 10th day of November, 2021 between **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE OF LANAO DEL NORTE/ ILIGAN** (hereinafter called the "Entity") and **MRBII CONSTRUCTION CORPORATION, 10 Golden Street, Gloria I Subdivision, Tandang Sora, Quezon City** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **REPAIR OF DAMAGED ROCKBULK HEAD AT THE BACK-UP AREA, Port of Kolambugan, Lanao del Norte with identification number of NRP-LDI - 002 - 2021** (hereinafter called "the Works") and the Entity has accepted the Bid for **NINETEEN MILLION EIGHT HUNDRED FORTY THOUSAND SEVEN HUNDRED SEVENTY FIVE PESOS AND TWENTY CENTAVOS ONLY (P 19,840,775.20)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of NINETEEN MILLION EIGHT HUNDRED FORTY THOUSAND SEVEN HUNDRED SEVENTY FIVE PESOS AND TWENTY CENTAVOS ONLY (P.19,840,775.20) or such other sums as may be ascertained, MRBII CONSTRUCTION CORPORATION agrees to perform the REPAIR OF DAMAGED ROCKBULK HEAD AT THE BACK-UP AREA, Port of Kolambugan, Lanao del Norte in accordance with his/her/its Bid.
4. The **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE OF LANA O DEL NORTE/ I LGAN** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
