



## Contract Agreement

THIS AGREEMENT, made this 25<sup>th</sup> day of November, 2019 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANA O DEL NORTE/ ILIGAN (hereinafter called the "Entity") and and KHAN KON CHI CONSTRUCTION and DEVELOPMENT CORP. (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Repair of Fendering System and Mooring System, Port of Kolambugan, Lanao del Norte** with identification number of **NRP-LDI-02-19** (hereinafter called "the Works") and the Entity has accepted the Bid for **SIXTEEN MILLION THIRTY THREE THOUSAND FIVE HUNDRED SEVENTY FIVE PESOS AND SIXTY SIX CENTAVOS ONLY (P 16,033,575.66)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.



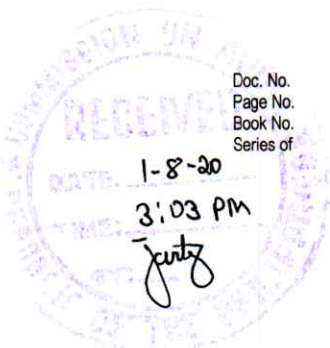
