




Contract Agreement

THIS AGREEMENT, made this 16th day of DECEMBER, 2019 between **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANAO DEL NORTE/ ILIGAN** (hereinafter called the "Entity") and **R. DE MESA CONSTRUCTION** (hereinafter called the "Contractor").



PORT MANAGER

WHEREAS, the Entity is desirous that the Contractor execute **Repair of Observation Tower, Port of Iligan, Iligan City** with identification number of **NRP-LDI-05-19** (hereinafter called "the Works") and the Entity has accepted the Bid for **EIGHT MILLION THREE HUNDRED FORTY THREE THOUSAND TWO HUNDRED EIGHTY-FIVE PESOS ONLY (P 8,343,285.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


WITNESS

1 In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2 The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:

- (f) Addenda and/or Supplemental/Bid Bulletins, if any;
- (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
- (h) Eligibility requirements, documents and/or statements;
- (i) DTI Business Certificate of Registration;
- (j) Mayor's Business Permit;
- (k) Tax Clearance;
- (l) PCAB Liscenced;
- (m) PhilGEPS Registration;
- (n) Performance Security;
- (o) Bid Securing Declaration; if any;
- (p) Notice of Award of Contract and the Bidder's conforme thereto;
- (q) Other contract documents that may be required by existing laws and/or the Entity.

3 In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


