




## Contract Agreement


THIS AGREEMENT, made this 9<sup>th</sup> day of November, 2019 between **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANA DEL NORTE/ ILAGAN** (hereinafter called the "Entity") and **LAJ TRUCKING AND BUILDERS, INC.** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Repair of Perimeter Fence Along Alternate Access Road, Port of Iligan, Iligan City** with identification number of **NRP-LDI-04-19** (hereinafter called "the Works") and the Entity has accepted the Bid for **TWENTY NINE MILLION SEVEN HUNDRED FORTY EIGHT THOUSAND FIVE HUNDRED SEVENTY FOUR PESOS AND TWENTY FOUR CENTAVOS ONLY (P 29,748,574.24)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- 1 In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (b) Specifications;
  - (c) Invitation to Bid;
  - (d) Instructions to Bidders;
  - (e) Bid Data Sheet;
  - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) DTI Business Certificate of Registration;
  - (j) Mayor's Business Permit;
  - (k) Tax Clearance;
  - (l) PCAB Liscenced;
  - (m) PhilGEPS Registration;
  - (n) Performance Security;
  - (o) Bid Securing Declaration; if any;
  - (p) Notice of Award of Contract and the Bidder's conforme thereto;
  - (q) Other contract documents that may be required by existing laws and/or the Entity.
- 3 In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


4 The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.



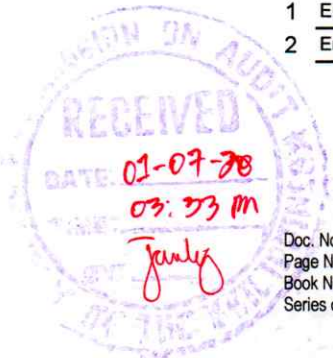
