



Contract Agreement


THIS AGREEMENT, made this 15th day of JULY, 2019 between **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANA DEL NORTE/ ILIGAN** (hereinafter called the "Entity") and **BRIMA CONSTRUCTION AND ENTERPRISES** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Upkeeping and Maintenance of the Port Physical Facilities for a period of Twelve (12) Months, Port of Iligan, Iligan City** with identification number of **CW - 001 - 2018** (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO MILLION FIVE HUNDRED NINETY FIVE THOUSAND PESOS (P 2,595,000.00) ONLY**, by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- (o) Bid Securing Declaration; if any;
- (p) Notice of Award of Contract and the Bidder's conforme thereto;
- (q) Other contract documents that may be required by existing laws and/or the Entity.


