


Contract Agreement


THIS AGREEMENT, made this 29th day of December, 2017 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANAO DEL NORTE/ ILIGAN (hereinafter called the "Entity") and AL FAHDEL CONSTRUCTION AND ENGINEERING (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute *Installation of Aluminum Cladding and G.I. Mini-Rib Ceiling Panels at PMO-Admin Building, Port of Iligan, Iligan City* with identification number of *NRP-LDI-10-17* (hereinafter called "the Works") and the Entity has accepted the Bid for FIVE MILLION EIGHT HUNDRED FIFTY ONE THOUSAND NINE HUNDRED FIFTY TWO PESOS AND EIGHTY EIGHT CENTAVOS ONLY (P 5,851,952.88) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- 1 In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2 The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Specifications;
 - (c) Invitation to Bid;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) DTI Business Certificate of Registration;
 - (j) Mayor's Business Permit;
 - (k) Tax Clearance;
 - (l) PCAB Licensed;
 - (m) PhilGEPS Registration;
 - (n) Performance Security;
 - (o) Bid Securing Declaration; if any;
 - (p) Notice of Award of Contract and the Bidder's conforme thereto;
 - (q) Other contract documents that may be required by existing laws and/or the Entity.
- 3 In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


