


Contract Agreement

THIS AGREEMENT, made this 27th day of December, 2017 between **PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANAOS DEL NORTE/ ILIGAN** (hereinafter called the "Entity") and **MAMSAR CONSTRUCTION AND INDUSTRIAL CORPORATION** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **RRepair of Damaged Jacketed RC Pile and Rock Bulkhead, Port of Kolambugan, Lanao del Norte** with identification number of **NRP-LDI-11-17** (hereinafter called "the Works") and the Entity has accepted the Bid for **SEVENTEEN MILLION EIGHT HUNDRED THIRTY SEVEN THOUSAND SEVEN HUNDRED THIRTY SIX PESOS AND SIXTY ONE CENTAVOS ONLY (P 17,837,736.61)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1 In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - (l) PCAB Licensed;
 - (m) PhilGEPS Registration;
 - (n) Performance Security;
 - (o) Bid Securing Declaration; if any;
 - (p) Notice of Award of Contract and the Bidder's conforme thereto;
 - (q) Other contract documents that may be required by existing laws and/or the Entity.

- 3 In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4 The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
