

## **Contract Agreement**

THIS AGREEMENT, made this \_\_\_\_\_\_\_ day of May, 2017 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANAO DEL NORTE/ILIGAN (hereinafter called the "Entity") and and MRBII CONSTRUCTION CORPORATION (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute *Repair of Lighting System, Port of Tubod, Lanao del Norte* with identification number of *NRP-LDI-01-17* (hereinafter called "the Works") and the Entity has accepted the Bid for THIRTEEN MILLION TWO HUNDRED TEN THOUSAND NINE HUNDRED THIRTEEN PESOS AND FIFTY EIGHT CENTAVOS (P 13,210,913.58)ONLY by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

  - (o) Bid Securing Declaration; if any;
  - (p) Notice of Award of Contract and the Bidder's conforme thereto;
  - Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.





4 The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
