




Contract Agreement

THIS AGREEMENT, made this 20th day of November, 2017 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANA DEL NORTE/ ILIGAN (hereinafter called the "Entity") and BRIMA CONSTRUCTION and ENTERPRISES (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute *Repair of Old Passenger Terminal Building, Port of Iligan, Iligan City* with identification number of *NRP-LDI-07-17* (hereinafter called "the Works") and the Entity has accepted the Bid for **SIX MILLION SEVEN HUNDRED SEVENTY THREE THOUSAND THREE HUNDRED SIXTY NINE PESOS AND NINETY THREE CENTAVOS ONLY (P 6,773,369.93)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

4 The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
