



Contract Agreement




WHEREAS, the Entity is desirous that the Contractor execute **Repair of RC Slab, RC Beam and Jacketing of RC Pile Berth 6, Port of Iligan, Iligan City** with identification number of **NRP-LDI-05-17** (hereinafter called "the Works") and the Entity has accepted the Bid for **TWENTY EIGHT MILLION NINE HUNDRED THIRTY EIGHT THOUSAND SEVENTEEN PESOS AND EIGHTY THREE CENTAVOS (P 28,938,017.83) ONLY** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (h) Eligibility requirements, documents and/or statements;
 - (i) DTI Business Certificate of Registration;
 - (j) Mayor's Business Permit;
 - (k) Tax Clearance;
 - (l) PCAB Licensed;
 - (m) PhilGEPS Registration;
 - (n) Performance Security;
 - (o) Bid Securing Declaration; if any;
 - (p) Notice of Award of Contract and the Bidder's conforme thereto;
 - (q) Other contract documents that may be required by existing laws and/or the Entity.

4 The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




