THIS AGREEMENT, made this _____ day of August, 2017 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANAO DEL NORTE/ILIGAN (hereinafter called the "Entity") and and LAJ TRUCKING AND BUILDERS, INC. (hereinafter called the "Contractor").



WHEREAS, the Entity is desirous that the Contractor execute Repair of RC Slab, RC Beam and Jacketing of RC Pile Berth 6, Port of Iligan, Iligan City with identification number of NRP-LDI-05-17 (hereinafter called "the Works") and the Entity has accepted the Bid for TWENTY EIGHT MILLION NINE HUNDRED THIRTY EIGHT THOUSAND SEVENTEEN PESOS AND EIGHTY THREE CENTAVOS (P 28,938,017.83) ONLY by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1 In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2 The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:

 - (c) Invitation to Bid;
 - (d) Instructions to Bidders;
 - (e) Bid Data Sheet:
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) DTI Business Certificate of Registration;
 - (i) Mayor's Business Permit;
 - (k) Tax Clearance;
 - (I) PCAB Lisenced:
 - (m PhilGEPS Registration;
 - (n) Performance Security;
 - (o) Bid Securing Declaration; if any;
 - (p) Notice of Award of Contract and the Bidder's conforme thereto;
 - (q) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.





4 The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
