THIS AGREEMENT, made this 14th day of November, 2018 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANA O DEL NORTE/ I L I G A N (hereinafter called the "Entity") and R. DE MESA CONSTRUCTION (hereinafter called the "Contractor").
