



## Contract Agreement

THIS AGREEMENT, made this NOV 13 2018 day of November, 2018 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANA DEL NORTE/ ILIGAN (hereinafter called the "Entity") and MRBII CONSTRUCTION CORPORATION (hereinafter called the "Contractor").

  
PORT MANAGER

WHEREAS, the Entity is desirous that the Contractor execute *Repair of Pavement of Back-up Area, Port of Kolambugan, Lanao del Norte* with identification number of *MRP-LDI-03-18* (hereinafter called "the Works") and the Entity has accepted the Bid for **TWENTY FIVE MILLION THREE HUNDRED TWENTY THOUSAND FOUR HUNDRED SIXTY FIVE PESOS AND THIRTY FIVE CENTAVOS ONLY (Php 25,320,465.35)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  
WITNESS

1 In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- (m) PhilGEPS Registration;
- (n) Performance Security;
- (o) Bid Securing Declaration; if any;
- (p) Notice of Award of Contract and the Bidder's conforme thereto;
- (q) Other contract documents that may be required by existing laws and/or the Entity.

3 In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4 The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
