



Contract Agreement

THIS AGREEMENT, made this **13 NOV 2018** day of November, 2018 between PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE LANA O DEL NORTE/ ILIGAN (hereinafter called the "Entity") and J.C. DELA VEGA CONSTRUCTION AND SUPPLY (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute *Repair of Water Reservoir and Pump-house, Port of Iligan, Iligan City* with identification number of *NRP-LDI-07-18* (hereinafter called "the Works") and the Entity has accepted the Bid for **FIFTEEN MILLION TWO HUNDRED FORTY SIX THOUSAND NINE HUNDRED TWENTY SIX PESOS ONLY (P 15,246,926.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

 - (p) Notice of Award of Contract and the Bidder's conforme thereto;
 - (q) Other contract documents that may be required by existing laws and/or the Entity.
- 3 In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
